NOTIFICATION

Whereas the Government of West Bengal for some time in the past has been considering introduction of "Online Sanction of Building Plan" for organizations like West Bengal Small Industries Development Corporation Ltd (WBSIDC) under EoDB initiative;

AND WHEREAS, the Government of West Bengal has already introduced **Online Single Window System for the Issuance of Construction Permits through Common Application Form (CAF)** (herein after referred to as **SWS-OBPAS**) named as "e-Grihanaksha", for receiving online application and issuing online permission for building plan and other allied services by organizations like WBSIDC ;

AND WHEREAS, WBSIDC has introduced an online system **SWS-OBPAS**, developed by leveraging the platform e-Grihanaksha (<https://obpsudma.wb.gov.in/>) of the Department of Urban Development & Municipal Affairs (UD&MA), Government of West Bengal, that will be made LIVE w.e.f. **1st August, 2022**;

AND WHEREAS, this online System (SWS-OBPAS) has been integrated with different NOC issuing Authorities through CAF, *namely*, West Bengal Fire & Emergency Services Department, Power Department, National Monument Authority, Airport Authority of India and ULC;


NOW, therefore, the Governor is hereby pleased to notify that WBSIDC shall receive online applications for building plan through CAF and shall issue permission /approval in the online mode mandatorily through web portal of SWS-OBPAS w.e.f. 1st August, 2022 without any physical touch points for document verification, payment of fees etc and WBSIDC shall not receive application, or issue permission /approval through WB e-District portal (<https://edistrict.wb.gov.in/PACE/>) after the scheduled date. However, the applications of building plan that are under process in the WB e-district portal for obtaining building plan sanction prior to 1st August, 2022, shall be processed and disposed of in the usual manner;

THIS ORDER is being issued for the interest of entrepreneurs/enterprises and top most priority shall be attached to this matter. All necessary actions including adequate publicity and awareness creation among the applicants/citizens and all stakeholders shall be arranged duly.
